For the case management of participants and clientele served by the Northeast Local area. You will need to provide advice on statistical quality control related to the clientele as defined by WIOA. Have previous experience in the implementation, development, support, and advice of the systems described above. Experience and knowledge of execution standards and its operation as well as the interrelation of this matter in the handling of cases. Mastery of the concept of the Single Management Center and having the ability to train the human resources that work every day with this matter. The proposal must contain the hourly fees and billing method to be used for the proponent.

MAINTENANCE AND TECHNICAL SUPPORT FOR INFORMATION SYSTEMS (MIS) / LAN/WAN NETWORK

Offer professional services and advice on the accounting system and the monitoring and use of different modules through support and training to the person. Also, request proposals to offer professional services at the end of fiscal year 2022-2023. The proposal must contain the hourly fees and the billing method to be used by the proponent.

MAINTENANCE AND TECHNICAL SUPPORT FOR THE LAN/WAN NETWORK

Including, but not limited to, providing maintenance at the operating system level to computer equipment, technical support for problems at the hardware level, detection of problems and/or recommendation of solutions, technical support, maintenance, and monitoring of networks for the communications between offices and configuration maintenance and knowledge of equipment and programs for data backup. The proposal must contain the hourly rates and the billing method to be used by the proponent.

WIOA TECHNICAL ASSISTANCE

Bidders must have experience and proven capacity in the Programs related to WIOA and with other state, federal and/or municipal funds related with workforce development. The activities for which a proposal is requested are the following:(a) technical assistance in matters related to the-programs, activities and services that are developed in the Local Area, (b) technical assistance in the preparation of the Quadrennial Plan, Regional Plan, Work Specifications, and respective modifications and (c) technical assistance in the identification of funds to develop activities related to the development of the workforce. The services may be offered to the Board of Mayors, Local Board, the staff, and the technical and managerial personnel of the Local Area. The proponent must include in your proposal professional profile, previous experience as an advisor, as well as the fees to be charged.

LEGAL CONSULTANCY IN MATTERS RELATED TO HUMAN RESOURCES AND ADMINISTRATION

Offer professional services and legal advice on matters related to the area of human resources and administration. Proponents must have experience in the regulations and application of the municipal code of Puerto Rico, Law 107-2020, and other related legal matters.
