# **PUBLIC NOTICE PROFESSIONAL SERVICES 2025-2026**

1. ADVICE AND SUPPORT FOR THE ELECTRONIC SYSTEM (CUSTOMER DATABASE)

For the case management of participants and clientele served by the Workforce Development of the Local Area Northeast (WDLAN). You will need to provide advice on statistical quality control related to the clientele as defined by WIOA. Have previous experience in the implementation, development, support, and advice of the systems described above. Experience and knowledge of execution standards and its operation as well as the interrelation of this matter in the handling of cases. Mastery of the concept of the Single Management Center and having the ability to train the human resources that work every day with this matter and board members. The proposal must contain the hourly fees. Development and maintenance of the WEB page and services integrated with our reporting systems. Must have proven experience in programs under the WIOA Act.

## MIP ACCOUNTING SYSTEM AND CLOSING OF THE FISCAL YEAR

Proponents must have experience and proven capacity in the MIP and FAS GOV Accounting Systems; They will offer advisory services, carry out follow-up tasks through support and training for personnel. Also include services to carry out the closing of the current fiscal year. The proposal must contain the hourly rates.

Offer services to create a work environment where there is harmony and maximum productivity, while reducing employee absenteeism and conflicts to the approximately 35 employees of the Workforce Development of the Local Area Northeast.
